
HEARING OFFICER ORDER

On May 28, 2015, a telephonic status conference was held. The petitioner stated that the related matter in circuit court has been resolved and it a consent decree will be filed within the next seven days. Once the consent decree is filed and approved, the petitioner anticipates it will file a motion to dismiss the above-captioned matter.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including September 17, 2015. The record in the above-captioned matter is now due on or before July 2, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on June 25, 2015, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing. If, however, a motion to dismiss the above-captioned matter is filed prior to the next status conference, the conference will be cancelled without further notice.


