
HEARING OFFICER ORDER

On June 5, 2014, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that discussions continue and that the parties have been exchanging drafts regarding the consent decree that is anticipated to be filed in state court on related cases.

By agreement, the record in the above-captioned matter is now due to be filed on or before August 23, 2014. The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including December 18, 2014. The petitioner states that once the consent decree is filed, the above-captioned appeal before the Board will be rendered moot.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on July 24, 2014, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




