HEARING OFFICER ORDER

On January 21, 2015, all parties participated in a telephonic status conference with the hearing officer. The petitioner stated that the related circuit court case has apparently been resolved and it has forwarded a consent decree to the respondent to be reviewed and signed. Petitioner opines that once the consent order is entered in the circuit court matter, this appeal will be moot and it will file a motion to voluntarily dismiss. By agreement, the record in the above-captioned matter is now due on or before March 13, 2015.

The petitioner stated that it will file an additional waiver of the statutory decision deadline to and including June 18, 2015.

The parties or their legal representatives are directed to appear at a telephonic status conference with the hearing officer on February 26, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.


