

PLEASE TAKE NOTICE that I have today filed with the Office of the Clerk of the Illinois Pollution Control Board the enclosed electronic correspondence confirming proof of service of the Administrative Citation on Respondent; a copy of which is herewith served upon you.

The Illinois EPA issued the Administrative Citation to Respondent on September 2, 2021 via third-party commercial carrier (United Parcel Service), with a request that the third-party commercial carrier record the recipient's signature upon delivery. 
