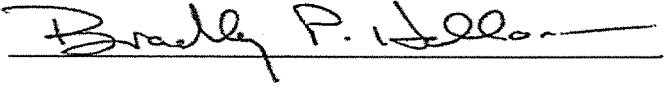
HEARING OFFICER ORDER

On May 14, 2015, the complainant e-mailed the status of the above-captioned matter to the hearing officer and the respondents. The complainant stated that a “concept letter” was received from DuPage County (County) and is currently being reviewed and discussed internally. The complainant has requested its consultant to provide a proposal for updating the flow monitoring data. Complainant stated that the updated monitoring would assist it in responding to the County.

To that end, it was agreed that the status conference be continued to the date and time noted below.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on July 1, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. 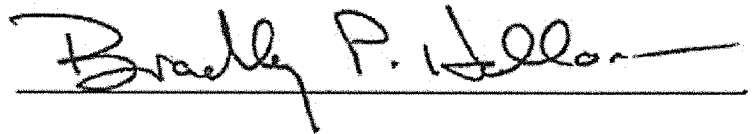
