

FACTS

- ## VIOLATIONS

On the basis of Field Inspector, Don Terry's, direct observation, he has determined that the Respondent has caused or allowed open dumping at the above described facility in a manner that

resulted in the following violations:

That on December 17, 2003, an on-site inspection of the facility disclosed the following:

1. The Respondent has caused or allowed litter at the facility in violation of 415 ILCS

5/21(p)(1).

CIVIL PENALTY

In accordance with 415 ILCS 5/42 (b)(4-5), the Respondent is subject to a civil penalty of \$1,500.00 for each of violations specified above. Additionally, should the Respondent elect to petition the Illinois Pollution Control Board under the review process described below, after an adjudicatory hearing, the Respondent shall be assessed the hearing costs incurred by the Pollution Control Board. The hearing cost would be in addition to the \$1,500.00 fine.

If you acknowledge the violations cited herein above, the civil penalty shall be due and payable no later than March 1, 2004. If you do not petition the Pollution Control Board for review of the Administrative Citation within 35 days of service of the Administrative Citation, or contest the Citation, any judgment that may be rendered against you shall specify the due date of the civil fine and any additional costs assessed against you.

When payment is made, your check should be made payable to the Jackson County's Treasurer Office and mailed to the attention of Shirley Dillinger Booker, Jackson County Treasurer, Murphysboro, Illinois, 62966. Also, please complete and return the enclosed remittance form, along with your payment, to assure proper credit.

If any civil penalty is not paid within the prescribed time, the law allows for the accumulation and payment of interest on the remaining unpaid balance. If any civil penalty is not paid when due, the Office of the State's Attorney shall be requested to initiate proceedings in Circuit Court to collect the penalty. In addition to the civil penalty, hearing costs, and interest, if any, the Jackson County State's Attorney may seek to recover their costs of litigation.

PROCEDURE FOR CONTESTING ADMINISTRATIVE CITATION

You have the right to contest this Citation, pursuant to 415 ILCS 5/31.1. If you elect to contest this Citation, you must file a Petition For Review with the Clerk of the Illinois Pollution Control Board. A copy of the Petition For Review shall be filed with Daniel Brenner, Assistant State's Attorney, Jackson County Courthouse, Third Floor, Murphysboro, Il 62966. **Your Petition For Review must be filed within 35 days of the date of service of the present citation on you. If you fail to file your Petition, a Default Order against you will entered by the Pollution Control Board.**







GENERAL REMARKS

During the above date and time, I conducted an inspection of the site listed above. This inspection was made as a follow up to one conducted on July 17, 2003. I was accompanied by Bart Hagston of the Jackson County Health Department.

At the time of this inspection, continuing violations of open dumping were observed. I observed no evidence of efforts to clean up the site since the previous inspection. Abandoned vehicles still litter the site. Many have broken windows allowing the materials in them to be exposed to the elements. At the time of the inspection, these vehicles were not in use, were not useable in their current condition, and were not stored in such a way as to protect any future use.

Besides abandoned vehicles, the waste I observed consisted of: waste tires, disposed motor vehicle parts, scrap metal and a variety of other materials not readily identifiable. Considering the type and amount of waste observed and the absence of any type of automotive repair business on site, one could reasonably assume that the materials were consolidated on the site for disposal.

My inspection concluded at approximately 10:30 am.

Violations Observed:

Item #5(21)(a): Cause or allow open dumping; Item #8(21)(p)(1): Cause or allow the open dumping of any waste in a manner which results in any of the following occurrences at the dump site: Litter: Open dumping of waste was observed at this location at the time of the inspection. The waste consisted of metal, motor vehicle parts, abandoned vehicles, tires on rims and other items and materials not readily identifiable.

Item #6 (21)(d) (1) and (2): Conduct any waste-storage, waste-treatment, or waste-disposal operation (1) without a permit, (2) in violation of any regulations or standards adopted by the board; Item #7 (21)(e): Dispose, treat, store, or abandon any waste or transport any waste into the state at/to sites not meeting requirements of the act; and Item #10(812.101)(a): Failure to submit an application for a permit to develop and operate a landfill: During this inspection, 24 abandoned vehicles, a trailer, a boat, a port-a-potty and a variety of other refuse was observed on the site. Since no residence or business is located on this site, it appears that all of the waste was generated off-site and brought to this location for disposal. There is no record of Edward Tow being issued a permit by the Agency to operate a disposal operation at this location and the site does meet the requirements for a waste management facility.

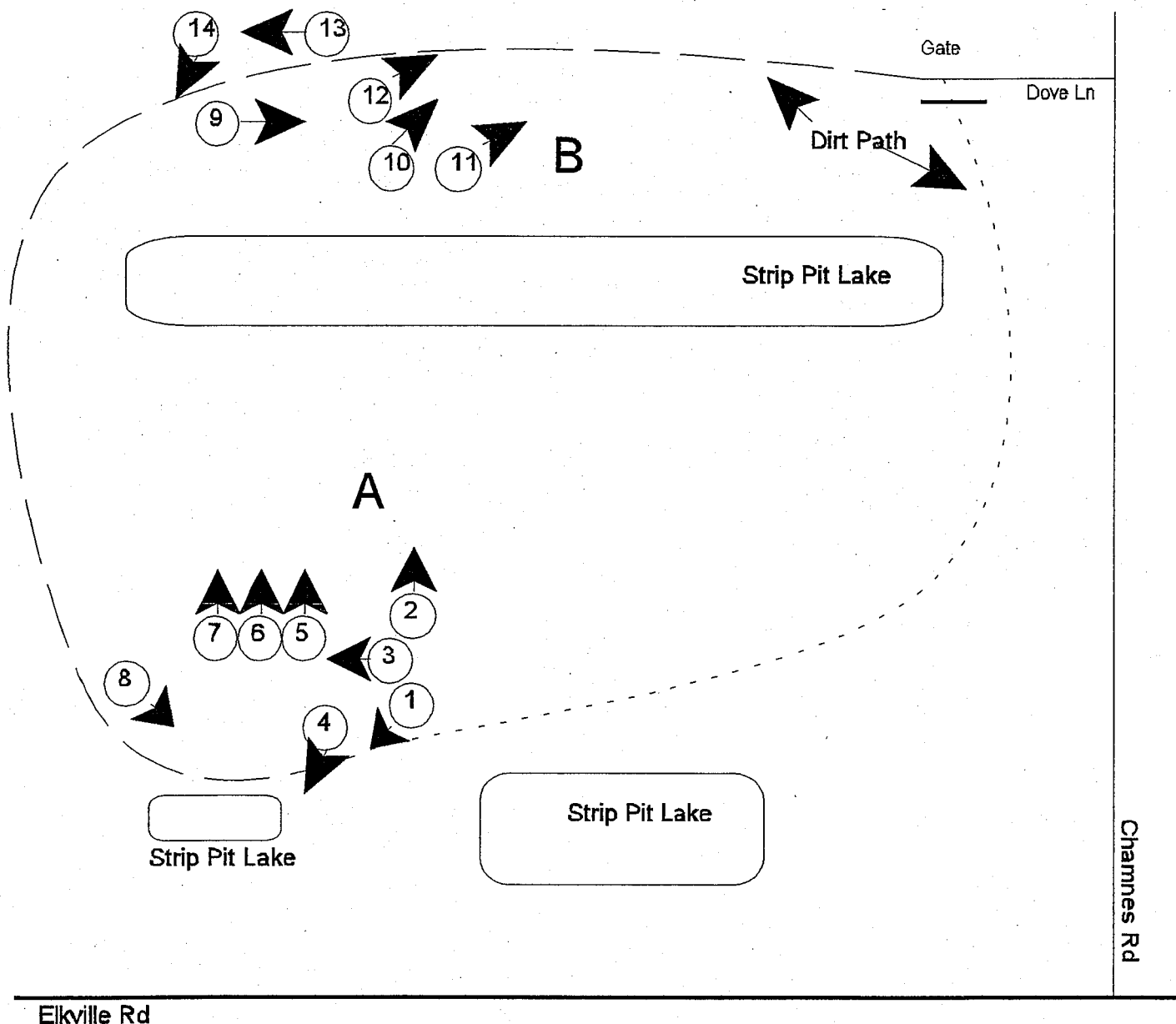



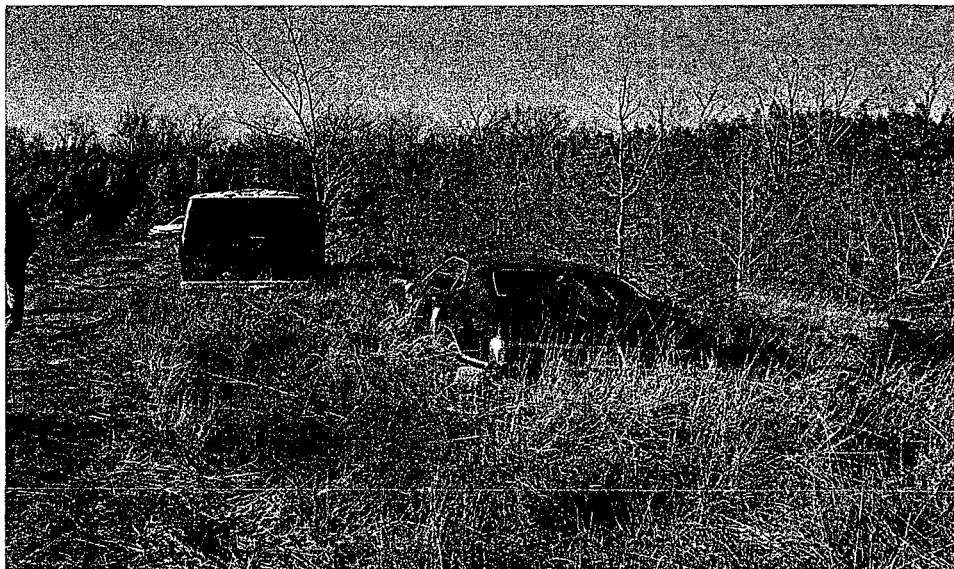
