MOTION TO EXTEND RECORD FILING DEADLINE TO DECEMBER 22, 2014

NOW COMES the Respondent, the Illinois Environmental Protection Agency ("Illinois EPA"), by and through its attorneys and pursuant to Section 101.522 and 105.116 of the Illinois Pollution Control Board ("Board") Regulations, 35 Ill. Adm. Code Sections 101.522 and 105.116, requests that the Board extend the deadline for filing the administrative permit record in this matter until December 22, 2014. In support of its Motion Respondent states as follows:

- 1. Petitioner filed this CAAPP Permit Appeal and Motion for Partial Stay on November 4, 2014, challenging certain conditions of the CAAPP Permit issued by Illinois EPA on October 16, 2014. The Petition was served on Illinois EPA on November 7, 2014. In accordance with Board Procedural Rules, the administrative permit record was to be filed by December 8, 2014.
- 2. On December 3, 2014, Petitioner filed a waiver, extending the Board's decision deadline until May 29, 2015.
- 3. The undersigned has been advised that Illinois EPA is in the process of assembling the administrative record for the relevant CAAPP Permit. However, for several reasons, including personnel absences related to the Thanksgiving holiday, assembling the complete permit record has not been completed. As of the date of filing this Motion, Respondent believes that a complete record can be assembled and filed with the Board by Monday, December 22, 2014.

4. The undersigned has contacted counsel for Petitioner and been advised that Petitioner has no objection to an extension until December 22, 2014 for filing the administrative permit record.

WHEREFORE, Respondent, Illinois Environmental Protection Agency, respectfully requests that the Board grant its request and extend the deadline for filing the administrative permit record in this matter to December 22, 2014.
