





**RESPONDENT'S MOTION FOR EXTENSION OF TIME**

NOW COMES the Respondent the Illinois Environmental Protection Agency ("Illinois EPA") by and through its attorneys and pursuant to Section 101.522 and 105.116 of the Illinois Pollution Control Board ("Board") Regulations, 35 Ill. Adm. Code Sections 101.522 and 105.116, moves the Board for an order granting Respondent additional time to file the administrative record in this matter. In support of this motion Respondent states as follows:

1. This matter was filed on October 29, 2014. The Office of the Attorney General first received contact from the Illinois EPA for representation in this matter on November 14, 2014. On November 18, 2014, the Office of the Attorney General agreed to represent the Illinois EPA.
2. Upon review of the file it became apparent the administrative record had not been filed.
3. Pursuant to Section 105.116 of the Board Regulations, the administrative record must be filed within 30 days after the filing of the petition for review.
4. The administrative record is currently due to the Board on or before November 28, 2014.
5. Section 105.116 of the Board Regulations affords the Hearing Officer authority to order a different date for filing the administrative record. Accordingly, the Respondent requests an


additional 30 days to compile and file the administrative record with the Board in this matter.

6. Counsel for the Respondent has conferred with counsel for Petitioner regarding the relief requested in this motion. Counsel for Petitioner has no objection to the request in this motion.

WHEREFORE, Respondent, Illinois Environmental Protection Agency, respectfully requests an Order extending the deadline for filing the administrative record in this matter for 30 days, pursuant to the requirements of Section 105.116 of the Board Regulations, 35 Ill. Adm. Code 105.116.
