
**HEARING OFFICER ORDER**

On February 25, 2016, all parties participated in a telephonic status conference with the hearing officer. Discussions first addressed the motion to withdraw filed by Huck Bouma PC on February 22, 2016. Pursuant to Section 101.400(b) of the Board's procedural rules, the motion was construed as a notice. Regardless, the respondent had no objection. The notice has been accepted and withdrawal is approved.

The remaining outstanding motions that have been filed by both parties will be addressed at the next status conference. The complainant's response to the respondent's motion to quash service will be filed on February 26, 2016. Respondent was given leave to reply on or before March 4, 2016. It is noted that the parties agreed to the conditions of inspection of the site.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on March 9, 2016, at 10:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. At the conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




