
HEARING OFFICER ORDER

On September 29, 2021, all parties participated in a telephonic status conference with the hearing officer. Discussions centered on the Illinois Environmental Protection Agency's (IEPA) motion for extension of time, filed September 22, 2021. The IEPA requests that an extension of time be granted as to its' Recommendation for Midwest Generation, LLC (Midwest) Joliet Station, Pond 2, to and including November 22, 2021. Also, on September 22, 2021, the IEPA timely filed its' Recommendation regarding Pond 1 & 3 at Midwest's Joliet Station.

Midwest does not object to IEPA's motion. IEPA's motion is granted. The IEPA's Recommendation as to Joliet Station, Pond 2, is now due on or before November 22, 2021.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on November 30, 2021, at 9:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




