HEARING OFFICER ORDER

On October 28, 2013 petitioner filed a status report stating that its current VOM emissions are substantially below the rate that will be allowable once the Agency issues a new FESOP permit. The Agency did not file a status report, but it is inferred that because petitioner is in compliance, the Agency is devoting its resources to other appeals. Petitioner believes that this appeal is needed to preserve its right to remain in lawful operation pending receipt of the permit. Accordingly, this docket is stayed until December 31, 2014, at which time the hearing officer will issue an order directing the parties to file an additional status report. This stay is not intended to prevent any movement on the case, but is only intended to spare petitioner the expense of appearing before the Board until the Agency is able to turn its attention to this permit.

There is an open waiver of the statutory decision deadline in this matter.
