## PETITIONERS' MOTION FOR VOLUNTARY DISMISSAL

NOW COMES Petitioners, National City Environmental, LLC ("NCE") and National City Recycling, LLC ("NCR"), by their undersigned attorney, and files their Motion for Voluntary Dismissal pursuant to 35 Ill. Adm. Code § 101.500. In support thereof, Petitioners state as follows:

- 1. On March 5, 2003, NCE and NCR timely filed three petitions with the Illinois Pollution Control Board ("Board"). Each petition concerned a different permit decision of the Illinois Environmental Protection Agency ("Agency"). These three petitions were docketed as PCB 03-138, PCB 03-139, and PCB 03-140 (the "Permit Appeals").
- 2. On March 7, 2003, NCE and NCR filed motions to consolidate the Permit Appeals.
- 3. On March 20, 2003, the Board granted NCE and NCR's motions to consolidate the Permit Appeals.
  - 4. The Permit Appeals remain pending before the Board.

5. As of the last status hearing on September 29, 2014, Petitioners and Respondent reported that the Permit Appeals will be resolved in conjunction with a related enforcement proceeding: *People v. National City Environmental, LLC, and National City Recycling, LLC*, PCB 06-115 (the "Enforcement Proceeding").

- 6. On October 21, 2014, the People filed a Stipulation and Proposal for Settlement in the Enforcement Proceeding that will resolve that proceeding once the Board approves it.
- 7. Because the parties to the Enforcement Proceeding intended that resolving the Enforcement Proceeding would additionally resolve the Permit Appeals, Petitioners here to the Permit Appeals no longer seek to appeal the permit decisions underlying the Permit Appeals.

WHEREFORE, Petitioners pray for an Order from the Board dismissing the Permit Appeals and closing the dockets of PCB 03-138, PCB 03-139, and PCB 03-140.
