HEARING OFFICER ORDER

On July 29, 2015, a telephonic status conference was held with the hearing officer. Summarizing the status, the complainant stated that the local high school, an un-named party, will be retaining a consultant by the end of August 2015, who will monitor and attempt to reduce stormwater flows to the 55th Street interceptor. Flow monitoring devices should be in place in September 2015.

The parties agreed to meet within the next three weeks to discuss what the flow monitoring results could possibly mean in terms of resolving this matter.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 15, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter.

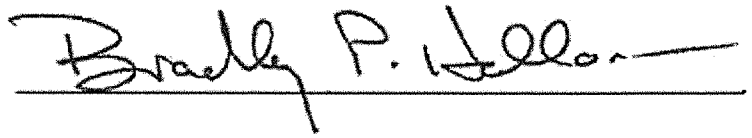
