HEARING OFFICER ORDER


On September 24, 2015, the parties submitted *via* electronic service an agreed request to hold in abeyance a ruling of any outstanding motions and matters while the parties continue with settlement discussions and attempt to draft a joint stipulation.

The parties agreed request is granted to the extent as follows. Respondent DuPage County's motion to deem facts admitted is held in abeyance. Complainant's motion for extension of time or in the alternative object to the request to admit is held in abeyance. Any motion practice related to complainant's answers or objections to respondent's DuPage County's request to admit is held in abeyance.

Further discussions on the parties request may be revisited at the next status conference.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on October 15, 2015, at 11:00 a.m. The telephonic status conference must be initiated by the complainant, but each party is nonetheless responsible for its own appearance. The complainant represented that it will notify the parties and the hearing officer of a call-in number prior to the next telephonic status conference. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter.


