5 titled In the Matter of Amendment to 35 Illinois  
6 Administrative Code Subtitle E: Agricultural  
7 Related Pollution.

10           On September 15, 2021 the Hearing  
11 Officer directed that any pre-filed testimony was  
12 to be filed with the Board by October 5th, 2021.  
13 We did not receive any pre-filed testimony by that  
14 date.

16 here who did not pre-file testimony for this  
17 hearing, but wishes to offer testimony?

18           Hearing none, we will move on to  
19 comments. Is there anyone present here to wishes
