PCB 20-16	<u>People of the State of Illinois v. Ironhustler Excavating, Inc. and</u> <u>River City Construction, LLC</u> (Land – Enforcement) – The Board granted the People's motion for summary judgment against Ironhustler and River City and denied Ironhustler's cross-motion for summary judgment. The Board found that both respondents violated the Environmental Protection Act and the Board's solid waste disposal regulations. The Board also assessed a civil penalty of \$80,000 against Ironhustler and \$35,000 against River City.	4-0 roll call vote
PCB 21-46	People of the State of Illinois v. Western Waterproofing Company, Inc., d/b/a Western Specialty Contractors, and Springfield Branch, LLC (Land, RCRA – Enforcement) – Upon receiving a stipulation, a proposed settlement, and an agreed motion for relief from the hearing requirement in this enforcement action involving a site in Sangamon County, the Board ordered publication of the required newspaper notice.	4-0 roll call vote
РСВ 22-2	People of the State of Illinois v. Wil Son Pallet LLC (Water, NPDES – Enforcement) – In this enforcement action concerning a Moultrie County facility, the Board granted relief from the hearing requirement of Section 31(c)(1) of the Environmental Protection Act (415 ILCS 5/31(c)(1) (2020)), accepted a stipulation and proposed settlement, and ordered Wil Son Pallet to pay a \$12,000 civil penalty and to cease and desist from further violations.	4-0 roll call vote
PCB 22-5	<u>Koppers Inc. v. Illinois Environmental Protection Agency</u> (Air – Permit Appeal) – The Board granted Koppers' motion for voluntary dismissal, dismissed this permit appeal, and closed the docket.	4-0 roll call vote
PCB 22-8	People of the State of Illinois v. Mohamed Elnatour, d/b/a Faatima <u>Citgo</u> (Air – Enforcement) – The Board accepted the People's complaint for hearing concerning Mohamed Elnatour's gas station located in Cook County.	4-0 roll call vote
PCB 22-10	People of the State of Illinois v. Kash Enterprises Incorporated, d/b/a Marathon (Air – Enforcement) – The Board accepted the People's complaint for hearing concerning Kash Enterprises' gas station located in Cook County.	4-0 roll call vote
