
**HEARING OFFICER ORDER**

On April 7, 2022, all parties participated in a telephonic status conference. The status conference centered on hearing dates and location. The petitioner is checking with its witnesses on availability for the dates of June 27 to June 30, 2022. It was surmised that the hearing will take no more than 2 days. It is anticipated that petitioner will present 8 witnesses and the Illinois Environmental Protection Agency one. The petitioner was directed to file a motion regarding its request to have one of their witnesses to testify remotely.

A potential hearing location that was discussed was the County Board Room in the Will County Office Building. That personnel at that location will be contacted to determine its availability. .

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on April 14, 2022, at 10:30 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. The petitioner is to provide a call-in number. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




