Good afternoon, Jonathan:

I have a question for you on No. 3.

We've been using "USC" in Board rules for years, including recently in new Part 204 on PSD and new Part 845 on CCR. And none of our "cleanup" rulemakings have been switching to "U.S.C." Even if we were to switch now to "U.S.C.", we're looking at very long time with most of the Board's rules reading "USC".

I see "U.S.C." in the SOS *Style Manual* (June 2004). But, with due respect to the *Style Manual*, having periods in "USC" seems like we're adding no clarity while doubling our key strokes. And within the rules themselves, "U.S.C." looks inconsistent with "CFR".

Is there any flexibility on this one? Thanks for considering.

1. In lines 218-219, strike "5285 Port Royal Road, Springfield, Virginia 22161" and add "5301 Shawnee Road, Alexandria, Virginia 22312".
2. In line 272, strike "2020" and add "2021".
3. In lines 301, 304, 307, 310, 313, 316, 319, 322, 325, and 329, strike "USC" and add "U.S.C.".
