


MOTION FOR VOLUNTARY DISMISSAL



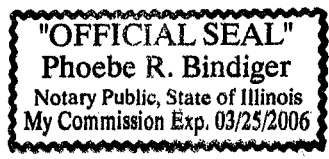
