
**HEARING OFFICER ORDER**

On August 24, 2022, all parties participated in a telephonic status conference. Counsel for Midwest Generation, LLC (MWG) (PCB 16-19) stated that it is awaiting the respondent to incorporate the relief granted in PCB 20-38 and PCB 20-39 for the Joliet Stations into their NPDES Permit. On August 23, 2022, MWG was granted a stay until December 1, 2022.

Counsel for INEOS Joliet, LLC, (INEOS) (PCB 16-24) reported that it has prepared a draft demonstration document that was forwarded to the respondent on August 16, 2022, for its review and comment.

The parties or their legal representatives in PCB 16-19 are directed to participate in a telephonic status conference with the hearing officer on November 17, 2022, at 10:30 a.m. The parties or their legal representatives in PCB 16-24 are directed to participate in a telephonic status conference with the hearing officer on November 17, 2022, at 11:00 a.m. The telephonic status conference must be initiated by the petitioner, but each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.

IT IS SO ORDERED.




