## **HEARING OFFICER ORDER**

On January 5, 2023, all parties participated in a telephonic status conference with the hearing officer. Complainant stated that he has requested that the Village of Bolingbrook and /or the respondent to provide him the stormwater records pertaining to the site and was "basically told by them to "F off" -in his words. Respondent stated that it denies that.

I directed the parties to file a proposed discovery schedule by January 27, 2023. I suggested that complainant may want to address his request for stormwater records in his written discovery. Complainant stated that he has already requested the stormwater records and that I am "basically telling him to F off too". Complainant does not appear to be interested in discovery where he stated that he already has everything he needs to go to hearing. Complainant also stated that he will continue to discuss the matter with "Molly" from the Illinois Attorney General's Office.

The parties or their legal representatives are directed to participate in a telephonic status conference with the hearing officer on February 9, 2023, at 10:30 a.m. The telephonic status conference must be initiated by the complainant, and the respondent to provide a telephone number. Each party is nonetheless responsible for its own appearance. At the status conference, the parties must be prepared to discuss the status of the above-captioned matter and their readiness for hearing.
