- 1. I am employed by the Illinois Environmental Protection Agency ("Illinois EPA"), as Assistant Counsel for Enforcement for the Bureau of Land.
- 2. As part of my duties, I am responsible for the preparation of Administrative Citations issued by the Illinois EPA and the negotiation and litigation of appeals filed pursuant to such Administrative Citations. As part of my job experience, I have also submitted travel vouchers for reimbursement.
- 3. I have reviewed the Illinois EPA Division of Legal Counsel File 144-03-AC, which relates to AC 03-27, *Illinois EPA v. Vince Harvey*, for the purpose of determining the costs expended by Illinois EPA.
- 4. I was the Illinois EPA attorney assigned to handle the hearing for AC 03-27, which was held in Kewanee. I was required to travel from Springfield to Kewanee and back for the hearing.
