CHAIR'S UPDATE

In this issue, I am pleased to share information on the Board's progress in rulemakings over the last few months. I highlight six rulemakings. The first two concern substantive changes to Board rules. The last four involve non-substantive updates of Board rules.

First, on December 7, 2022, the Illinois Environmental Protection Agency (IEPA) filed a "fast-track" rulemaking proposal to remove so-called "SSM"—startup, shutdown, and malfunction—provisions from the Board's air pollution rules. Since then, the Board proposed the amendments for first notice, held two public hearings, received public comment, and adopted a second-notice opinion and order. The amendments proposed for second notice, which are substantively unchanged from IEPA's proposal, will now be considered by the Joint Committee on Administrative Rules (JCAR). See [docket R18-23](#).

Second, after holding two public hearings and receiving public comment, the Board proposed first-notice rules on January 19, 2023, for permitting, operating, and closing general construction or demolition debris (GCDD) recovery facilities. The GCDD rules are required by Public Act 102-310 (eff. Aug. 6, 2021), under which the Board must adopt final rules within one year after receiving IEPA's proposal, *i.e.*, by August 1, 2023. The Board expects to proceed to second notice at its May 4, 2023 meeting. See [docket R23-17](#).

The four non-substantive rulemakings concern the Board's regulatory-review initiative, our undertaking to update, streamline, and clarify the Board's rules across multiple media and subject areas. In each of these four rulemakings, the Board held two public hearings and received public comment. On February 16, 2023, the Board proposed first-notice amendments to its Subtitle E agriculture-related water pollution rules. The 45-day public comment period just ended in that rulemaking. See [docket R18-25](#). On March 2, 2023, the Board adopted final amendments to all 11 Parts of its Subtitle C water pollution rules. See [docket R18-23](#). On April 18, 2023, JCAR issued Certifications of No Objection to the proposed amendments of the Board's Subtitle F public water supply rules (see [docket R18-26](#)) and Subtitle I atomic radiation rules (see [docket R18-28](#)). The Board expects to adopt final amendments in those two rulemakings at its May 4, 2023 meeting.

The above rulemakings are discussed in greater detail later in this issue of the *Environmental Register*. In addition, you can find information on all the Board's pending rulemakings at <https://pcb.illinois.gov/>.

I conclude with sad news for the Board and its staff. At our April 6, 2023 meeting, we issued a proclamation commemorating and congratulating former Board Member Cynthia Santos, who recently left the Board after serving so ably for over six years. Throughout her tenure, Ms. Santos eagerly took on the Board's caseload, including assignments as lead Board Member for numerous permit appeals, regulatory-relief requests, and rulemakings. In all Board proceedings, she reliably brought her considerable knowledge and experience to bear. We will greatly miss



her invaluable insights. I again express our profound thanks to Ms. Santos and wish her many years of health, happiness, and professional success.

RULEMAKING UPDATE

Board Proposes Clean Air Act “Fast-Track” Amendments for First Notice

On December 15, 2022, the Board accepted for hearing a rulemaking proposal filed by the Illinois Environmental Protection Agency (IEPA) under the “fast-track” provisions of Section 28.5 of the Environmental Protection Act. Section 28.5 requires the Board to meet expedited rulemaking deadlines when considering rules required by the Clean Air Act, as amended by the Clean Air Act Amendments of 1990 (CAAA). Without commenting on the substantive merits of IEPA’s proposal, the Board directed the Clerk to submit the proposal for first-notice publication in the *Illinois Register*. That publication took place on December 30, 2022.

IEPA seeks to amend air pollution rules of the Board at 35 Ill. Adm. Code 201, 202, and 212 by removing provisions that, according to IEPA, allow for advance permission to continue operating during a malfunction or violate emission limitations during start-up. The proposal is intended to meet the State’s obligations under the CAAA. If the Board adopts the rules, IEPA will submit them to the United States Environmental Protection Agency as a State Implementation Plan or “SIP” revision.

Board Proposes Non-Substantive Amendments to Water Pollution Rules for Second Notice

On January 19, 2023, the Board proposed non-substantive amendments to its water pollution rules for second-notice review by the Joint Committee on Administrative Rules (JCAR). These proposed amendments are part of a larger undertaking by the Board to update its rules across multiple media and subject areas. The proposal will remove unnecessary language, replace outdated text, update statutory references, and reorganize provisions for clarity.

During the first-notice comment period, the Board received comment from the Illinois Environmental Protection Agency. JCAR also suggested numerous changes to the Board’s first-notice proposal. The proposed second-notice amendments affect all 11 Parts of the Board’s Subtitle C water pollution rules, *i.e.*, Parts 301 through 310 and 312 of Title 35 of the Illinois Administrative Code.

Board Proposes GCDD Recovery Facility Rules for First Notice

On January 19, 2023, the Board proposed first-notice rules for permitting, operating, and closing general construction or demolition debris (GCDD) recovery facilities. This rulemaking began when the Illinois Environmental Protection Agency (IEPA) filed its proposal with the Board to comply with Public Act 102-310 (eff. Aug. 6, 2021). IEPA was required to—and did—propose GCDD recovery facility rules within one year after the Public Act’s effective date. Now, under that new law, the Board must adopt final rules by August 1, 2023, *i.e.*, within one year after receiving IEPA’s proposal.

During this rulemaking, the Board held two public hearings, received testimony from IEPA, and received a public comment from the Illinois Attorney General’s Office. For first notice, the Board proposed that the rules appear as a new Part (Part 820) in the Board’s waste disposal rules (35 Ill. Adm. Code 820). *Illinois Register* publication of this first-notice proposal took place on February 10, 2023, starting a period of at least 45 days during which anyone may file a public comment with the Board concerning the proposed rules.

The rulemaking is captioned Proposed 35 Ill. Adm. Code 820 General Construction or Demolition Debris Recovery Facilities, docket R23-17. Board Proposes Non-Substantive Amendments to Agriculture-Related Water Pollution Rules for First Notice

On February 16, 2023, the Board proposed non-substantive amendments to its agriculture-related water pollution rules for first-notice publication in the *Illinois Register*. The Board proposed these first-notice amendments to remove unnecessary language, replace outdated text, update statutory references, and otherwise clarify the rules. This rulemaking is part of a larger undertaking to update the Board’s rules across multiple media and subject areas.

After adopting a proposal for public comment and holding two public hearings, the Board received a public comment from the Illinois Environmental Protection Agency, as well as a collective public comment from the Illinois Beef Association, Illinois Farm Bureau, Illinois Milk Producers Association, and the Illinois Pork Producers Association. The amendments proposed for first notice impact all four Parts of the Board’s Subtitle E agriculture-related water pollution rules, *i.e.*, Parts 501, 502, 503, and 506 of Title 35 of the Illinois Administrative Code. The proposal was published in the *Illinois Register* on March 10, 2023, beginning a period of at least 45 days during which anyone may file a public comment with the Board concerning the first-notice rules.

Board Adopts Non-Substantive Amendments to Water Pollution Rules

On March 2, 2023, the Board issued a final order adopting non-substantive amendments to its water pollution rules. These amendments affect all 11 Parts of the Board's Subtitle C rules, *i.e.*, Parts 301 through 310 and 312 of Title 35 of the Illinois Administrative Code. These amendments are part of a larger undertaking by the Board to update its rules across multiple media and subjects. The amendments remove unnecessary language, replace outdated text, update statutory references, and reorganize provisions for clarity.

During this rulemaking, the Board held public hearings and received testimony and public comment from the Illinois Environmental Protection Agency. In addition, the Joint Committee on Administrative Rules (JCAR) suggested numerous changes to the rules proposed by the Board at first notice. At its February 14, 2023 meeting, JCAR issued a Certification of No Objection for all the amendments in the Board's proposal. The amendments will take effect upon filing with the Secretary of State.

Board Proposes Non-Substantive Amendments to Public Water Supply Rules for Second Notice

On March 2, 2023, the Board proposed non-substantive amendments to its public water supply rules for second-notice review by the Joint Committee on Administrative Rules (JCAR). These proposed amendments are part of a larger undertaking by the Board to update its rules across multiple media and subject areas. The proposal will remove unnecessary language, replace outdated text, update statutory references, and reorganize provisions for clarity. The rulemaking is captioned [Amendments to 35 Ill. Adm. Code Subtitle F: Public Water Supply](#), docket R18-26.

During this rulemaking, the Board held public hearings and received testimony and public comment from the Illinois Environmental Protection Agency. In addition, JCAR suggested numerous changes to the rules proposed by the Board at first notice. The Board's proposed second-notice amendments impact nine of the ten Parts of the Board's Subtitle F rules, *i.e.*, Parts 601 through 604, Part 611, and Parts 615 through 618 of Title 35 of the Illinois Administrative Code. At its April 18, 2023 meeting, JCAR issued a Certification of No Objection to the amendments proposed by the Board in this non-substantive rulemaking. JCAR also issued a Statement of Recommendation in which JCAR "recommended that the Board in its next substantive rulemaking on this Part [602] amend Sections 602.111 and 602.116 to include the standards by which the Environmental Protection Agency will exercise the specific discretionary powers delegated to it by those Sections."

Board Proposes Non-Substantive Amendments to Atomic Radiation Rules for Second Notice

On March 2, 2023, the Board proposed non-substantive amendments to its atomic radiation rules for second-notice review by the Joint Committee on Administrative Rules (JCAR). This rulemaking is part of a larger undertaking to update the Board's rules across multiple media and subject areas. The proposal will remove unnecessary language, replace outdated text, update statutory references, and reorganize provisions for clarity.

Before proceeding to first notice, the Board adopted a proposal for public comment and held two public hearings. The Board received comment and testimony from the Illinois Emergency Management Agency. JCAR also suggested numerous changes to the Board's first-notice proposal. The amendments proposed for second notice impact both Parts of the Board's Subtitle I atomic radiation rules, *i.e.*, Parts 1000 and 1010 of Title 35 of the Illinois Administrative Code. At its April 18, 2023 meeting, JCAR issued a Certification of No Objection to the proposed amendments.

Board Proposes Clean Air Act “Fast-Track” Amendments for Second Notice

On April 6, 2023, the Board adopted an opinion and order proposing amendments to its air pollution rules for second-notice review by the Joint Committee on Administrative Rules (JCAR). The amendments would remove provisions that allow the Illinois Environmental Protection Agency (IEPA) to grant emission sources advance permission to continue operating during a malfunction or violate emission standards during startup. Under these provisions, compliance with IEPA's advance permission is a *prima facie* defense to an enforcement action. The United States Environment Protection Agency found these provisions to be inconsistent with the Clean Air Act.

IEPA initiated this rulemaking by filing a proposal under the “fast-track” procedures of the Environmental Protection Act (415 ILCS 5/28.5), which require the Board to proceed toward rule adoption by meeting a series of prescribed deadlines. During this rulemaking, the Board held two public hearings and received numerous public comments. JCAR also suggested changes to the Board's first-notice proposal. The amendments proposed for second notice impact three Parts of the Board's air pollution rules, *i.e.*, Parts 201, 202, and 212 of Title 35 of the Illinois Administrative Code.

[R18-23](#) Amendments to 35 Ill. Adm. Code Subtitle C: Water Pollution (Water) – The Board adopted a second-notice opinion and order in this rulemaking to non-substantively amend the Board’s water pollution regulations.

[R23-17](#) Proposed 35 Ill. Adm. Code 820 General Construction or Demolition Debris Recovery Facilities (Land) – The Board adopted a first-notice proposal in this rulemaking to create a new Part 820 of the Board’s waste disposal regulations, which would establish rules for permitting, operating, and closing general construction or demolition debris (GCDD) recovery facilities.

[R23-10](#) UIC Update, USEPA Regulations (July 1, 2022 through December 31, 2022) (Land) – The Board dismissed this reserved “identical-in-substance” docket because the United States Environmental Protection Agency did not amend its corresponding underground injection control (UIC) regulations during the update period of July 1, 2022 through December 31, 2022.

[R23-11](#) RCRA Subtitle D (Municipal Solid Waste Landfill) Update, USEPA Regulations (July 1, 2022 through December 31, 2022) (Land) – The Board dismissed this reserved “identical-in-substance” docket because the United States Environmental Protection Agency did not amend its corresponding municipal solid waste landfill (MSWLF) regulations during the update period of July 1, 2022 through December 31, 2022.

[R23-13](#) UST Update, USEPA Regulations (July 1, 2022 through December 31, 2022) (Land) – The Board dismissed this reserved “identical-in-substance” docket because the United States Environmental Protection Agency did not amend its corresponding underground storage tank (UST) regulations during the update period of July 1, 2022 through December 31, 2022.

[R23-14](#) Wastewater Pretreatment Update, USEPA Regulations (July 1, 2022 through December 31, 2022) (Water) – The Board dismissed this reserved “identical-in-substance” docket because the United States Environmental Protection Agency did not amend its corresponding wastewater pretreatment regulations during the update period of July 1, 2022 through December 31, 2022.

[R23-16](#) Definition of VOM Update, USEPA Regulations (July 1, 2022 through December 31, 2022) (Air) – The Board dismissed this reserved “identical-in-substance” docket because the United States Environmental Protection Agency did not amend its corresponding air pollution control regulations during the update period of July 1, 2022 through December 31, 2022.

ADMINISTRATIVE CITATIONS

[AC 18-11](#) IEPA v. Michael Crank, individually and d/b/a Crank Tree Service (Land) – In this administrative citation action involving a Saline County site, the Board accepted the parties’ stipulation and proposed settlement, found that Michael Crank violated Section 21(p)(1) of the Environmental Protection Act (415 ILCS 5/21(p)(1) (2020)), and ordered Crank to pay the statutory civil penalty of \$1,500. The Board also dismissed the alleged violations of Section 21(p)(3) and (p)(7) of the Environmental Protection Act (415 ILCS 5/21(p)(3), (p)(7) (2020)) and granted the parties’ motion to dismiss Crank’s petition contesting the citation.
