

The Illinois Pollution Control Board gives notice of public hearing regarding rule changes proposed by the Board on October 19, 2023: Definition Of VOM, USEPA Amendments (January 1, 2023, through June 30, 2023), R24-8. Interested persons are invited to attend the hearing or to submit written comments. The docket R24-08 proceeding relates to the Illinois definition of "volatile organic material" (VOM) in 35 Ill. Adm. Code 211.7150 of the Illinois air pollution control rules. Interested persons are invited to attend the hearings or to submit written comments. The Public Hearing will be held on December 7, 2023, at 11:30 a.m. at the Michael A. Bilandic Building, Room N505, 160 N.
