**HEARING OFFICER ORDER**

On February 22, 2024, the parties were scheduled to participate in a telephone status conference. Respondents were unable to attend due to the cellular phone outage. The Agency reported that the site was reinspected yesterday, and people were cleaning up the burn area. There were about six piles of larger limbs and tree trunks along the western perimeter, and the largest tree trunks were in the northern pile. If the northern pile will take longer than 30 days to remove, the Agency needs a monthly quota that will be met. The Agency further advised respondents about burning in compliance with the Act.
