

**HEARING OFFICER ORDER**

On May 14, 2024, the parties reported in an email that the City of Chicago hearing officer (City of Chicago, Department of Administrative Hearings, Environmental Division) issued his decision in the related matter on June 1, 2023. The City of Chicago appeal of the decision on June 30, 2023, remains pending. As such, the parties request a continuance of this permit appeal conference call previously scheduled for May 23, 2024. IT IS SO ORDERED.




