Dear Ms. Wheeler:

I am enclosing copies of subpoenas for deposition, and checks, for four people.

In Interrogatory #1 and the Definitions and Instructions Section F, Q C Finishers asked for the addresses of your potential witnesses. Your answers did not include them and you did not object to the request. Q C Finishers objects to your failure to provide the addresses and other requested information.

Given the impending deadline for the service of subpoenas I called your office on July 2nd to get the addresses and spoke with Joel Sternstein who told me on July 3rd that he was unable to persuade the IEPA attorney to provide him with the addresses.
