The USEPA corrected typographical errors, incorrect citations, and ambiguous language in the three rules. The Board proposes amendments to the Illinois hazardous waste rules to reflect the USEPA's updates.

December 6, 2023 (88 FR 84710)

The USEPA withdrew eight non-substantive and technical revisions amended in the RCRA Subtitle C Generator Improvements, Pharmaceuticals, and Definition of Solid Waste rules published on August 9, 2023 (88 FR 54086) due to adverse public comments.
