PETCO PETROLEUM CORPORATION'S REQUEST FOR AN EXTENSION OF TIME TO FILE AMENDED AFFIRMATIVE DEFENSES TO THE FIRST AMENDED COMPLAINT

COMES NOW Respondent Petco Petroleum Corporation ("Petco"), by and through its undersigned counsel, and for its Request for an Extension of Time to File Amended Affirmative Defenses to the First Amended Complaint, states as follows:

1. On August 8, 2024, the Board issued its Order addressing the People of the State of Illinois' ("People") Motion to Strike Respondent's Affirmative and Additional Defenses to the First Amended Complaint and Immaterial Matter ("Motion to Strike"). The August 8th Order struck with prejudice Petco's alleged affirmative defenses C and L and struck without prejudice Petco's alleged affirmative defenses C and L and struck without prejudice Petco's alleged affirmative defenses A, B, D, E, F, G, J, and K and a portion of affirmative defense H. The August 8th Order directed Petco to amend affirmative defenses B, D, E, F and I, as well as the remaining portion of affirmative defense H by Monday, September 9, 2024.

2. On August 22, 2024, the Board issued a second Order addressing Petco's Motion to Dismiss Counts 62 Through 73 of the First Amended Complaint ("Motion to Dismiss"). The August 22nd Order denied the Motion to Dismiss and struck with prejudice "the remaining portion of Petco's Affirmative Defense H pertain[ing] to the same Section 13-205 statute of limitations argument raised in the motion to dismiss." (August 22nd Order, p. 5).

3. In light of the two orders, which both pertain to Petco's affirmative defenses

pleaded in response to the First Amended Complaint, Petco requests a three (3) week extension

of time to file its amended affirmative defenses, such that the deadline be set to Monday,
