The Illinois Pollution Control Board gives notice of public hearing regarding rule changes proposed by the Sierra Club, Natural Resources Defense Council, Environmental Defense Fund, Respiratory Health Association, Chicago Environmental Justice Network, and Center for Neighborhood Technology on June 27, 2024: Proposed Clean Car and Truck Standards: Proposed 35 Ill. Adm. Code 242, R24-17. Interested persons are invited to attend the hearings or to submit written comments. The proposed amendment, if adopted, may ultimately result in submission to the USEPA of an amendment to Illinois' state implementation plan (SIP). Section 110(a)(2) of the Federal Clean Air Act (42 U.S.C. 1 §7410(a)(2) (2023)). The Public Hearing will be held on December 2, 2024, and December 3, 2024, beginning at 10:00 AM by VIDEO CONFERENCE at the Michael A. Bilandic Building, 160 N. LaSalle Street, Room C 500, Chicago, Illinois AND Illinois Department of Transportation, Hanley Building, Auditorium, 2300 S. Dirksen Parkway, Springfield, Illinois. 
