Illinois Pollution Control Board gives notice of public hearing regarding rule changes proposed by the Sierra Club, Natural Resources Defense Council, Énvironmental Defense Fund, Respiratory Health Association. Chicago Environmental Justice Network, and Center for Neighborhood Tech-nology on June 27, 2024: Proposed Clean Car and Truck Standards: Pro-posed 35 III. Adm. Code 242, R24-Interested persons are invited to attend the hearings or to submit writ-ten comments. The proposed amendment, if adopted, may ultimately result in submission to the USEPA of an amendment to Illinois' state implementation plan (SIP). Section 110(a)(2) of the Federal Clean Air Act (42 U.S.C. I §7410(a)(2) (2023)). 
