MINUTES OF FORMAL BOARD MEETING
THURSDAY, JANUARY 20, 1972, 309 W. WASHINGTON ST., CHICAGO, ILL.

The Board first heard a motion by Rep. Harold Katz to intervene and present further evidence on behalf of the United Auto Workers in #71-238, General Electric Co. A transcript of the proceedings was taken. General Electric and the Attorney General were represented. Upon agreement of the parties Mr. Katz is to submit a more detailed written statement of the reasons for concern by February 8, upon which the Board will determine the motion. Action on the proposed opinion was deferred pending further comments on that opinion by the parties February 8.

The following opinions and orders were adopted: #71-265, Minerva, after amendment to provide that if wet baffles do not achieve compliance the Board will consider further action (4-0); #71-283, Logan, after amendment to require operation within the regulations even after a permit is obtained and to note the expectation that additional pictures of the site will be received relative to the question of penalty (4-0); and #71-307, Ford, after an amendment raising the penalty to \$1000, over Mr. Currie's dissent (4-0).

The following action was taken in new cases: #72-9, Deerfield, wait recommendation; 72-10, Packaging Corp., hearing mandatory; 72-11, Congregation Am Echod, wait recommendation; 72-12, North Shore Industrial Centre, wait recommendation; 72-13, Will County Landfill, hearing mandatory; 72-14, Orick, verify and then grant; 72-15, Moweaqua, DC to draft opinion to dismiss for Jan. 24; 72-16, McCormick, and 72-17, Fritsch, hearing mandatory; 72-18, Arcola, 4-0 hearing; 72-19, -20, -21, Peoria State Hospital, DC to draft opinion to dismiss for Jan. 24; 72-22, Tucker, verify and then grant; 72-23, Baker, hearing mandatory; 72-24, Metropolitan Sanitary District, 4-0, hearing; 72-25, Bowan, and 72-26, Lake Zurich, hearing mandatory; 72-27, Central Soya, wait recommendation.

Minutes for January 6 and 17 were approved 4-0. Mr. Harker's suggested additional provisions for mine wastes, #R71-25, were authorized for publication and hearing 4-0.

The motion to amend the order in #71-44, USI, was deferred until January 24. A motion for revision in # 71-53, Rhodes was referred to EPA for response before Board decision. A motion for revision in #71-287, Sauget, was noted, Mr. Dumelle agreeing to check the record regarding a possible error in interim dates and Mr. Currie suggesting that in other respects the motion should be denied. A motion to dismiss #71-306,

Tollway, was noted and Mr. Currie said had already been denied. #71-375, Achilli Builders, was dismissed as moot 4-0 on request of both parties since the Elgin sewer ban had been lifted and the permit would be granted.

Mr. Dumelle noted he would phrase additional questions for Edison on Emergency Core Cooling.
