MINUTES OF REGULAR BOARD MEETING September 6, 1972 309 W. Washington, Chicago

All Board Members were present save Mr. Currie.

Discussion of the motions for stay in #R71-23, Air Regulations, filed by four steel companies was held. The Board voted 4-0 to ask parties to appear for oral argument on September 12, 1972. Mr. Karaganis of the Office of the Attorney General agreed to notify the parties of that decision and Mr. Lawton said he would write an order.

Parties appeared in #72-253, Olin Corporation on a motion for non-disclosure. Mr. Bullwinkel, attorney for the Petitioner agreed to waive decision date to October 10, 1972. The Board voted 4-0 on a conditional order on motion for non-disclosure and Mr. Lawton agreed to prepare the order.

In #72-49, Benjamin Harris, a motion to dismiss the hearing officer and grant a continuance was denied by a vote of 3-0. Mr. Henss agreed to prepare an order. Mr. Lawton did not participate in the discussion or decision on the motion.

A motion for non-disclosure in #72-49, Benjamin Harris, was denied by a vote of 3-0. Mr. Parker agreed to prepare an order. Mr. Lawton did not participate in the discussion or decision on the motion.

Modification orders were adopted by a vote of 4-0 in ##70-34, Granite City and 72-143, City of Springfield.

The Board then adopted opinions and orders in the following cases by a vote of 4-0: ##71-333, Howe v. Edison; 71-365, Urbana; 72-2, Salem; 72-41 and 72-144, Richardson; 72-122, Galena; 72-131 and 72-132, Crane Packing.

The Board voted 4-0 to grant variances in ##72-234, Chicago Port District; 72-235, Imperial Smelting; 72-237, GAF; 72-239 and 72-240, Illinois Power. Mr. Lawton said he would prepare opinions and orders.

Opinions and orders were adopted by a vote of 4-0 in: ##72-244, Ohlman; 72-263, Aladdin; 72-293, E.N. Maisel.

In #72-363, Granite City, Mr. Lawton had prepared an opinion dismissing the variance request and the Board adopted it by a vote of 4-0.

Parties appeared in #72-180, Borden and discussion of an application for non-disclosure was held. The Board then requested that an affidavit be filed and discussion was put over to the afternoon session.

The meeting was recessed for lunch until 1:30 P.M.

Discussions were held in the following cases and set for decision September 12, 1972: ##72-1, C & S, Mr. Henss to prepare an opinion; 72-23, Baker, Mr. Parker to prepare an opinion; 72-136, Rock Island, Mr. Lawton agreed to prepare an opinion and 72-171, Jacobs, Mr. Dumelle agreed to prepare an opinion.

Discussion of #R72-7, Air Standards, was put over to September 26, 1972.

Mr. Lawton announced that the Board meeting scheduled for September 19, 1972, would be cancelled. The Board meeting for October 10, 1972 would not be changed even though a holiday was being observed on October 9, 1972.

By a vote of 4-0, the Board adopted a motion in #R72-12 removing the burden of transcript costs from parties in enforcement hearings. Mr. Dumelle made a motion to remove the burden of transcript costs from petitioners in variance and permit proceedings. The motion was tabled for want of a second.

A petition for new hearings on Air Standards filed by the Metropolitan Incinerator Assoc. and the Incinerator Institute of America (#R72-12) was denied by a vote of 4-0.

Motions to extend time for filing amended variance petitions were granted by a vote of 4-0 in ##72-246, Lewis & Clark and 72-334, Highwood.

Parties appeared in #72-180, Borden, with the requested affidavit. A conditional order of non-disclosure was adopted by a vote of 4-0 and Mr. Parker agreed to prepare the order.

Minutes of Board meetings for August 22 and 23, August 28 and August 29, 1972, were adopted by a vote of 4-0.

Actions in new cases were as follows: ##72-356, Hawley Products, the Board voted 4-0 to request additional information, Mr. Dumelle to prepare an order; 72-357, Olin Corp., petition ordered held for E.P.A. recommendation; 72-358, City of Georgetown, petition dismissed by a vote of 4-0, Mr. Parker to prepare an order; 72-359, Knox County Sanitary Landfill, a hearing was authorized by a vote of 4-0; 72-360, Village of Roscoe, the Board voted 4-0 to request additional information and Mr. Henss agreed to prepare an order; 72-361, Bederman, petition ordered held for E.P.A. recommendation; 72-362, Donald Gregg, hearing authorized by a vote of 4-0, Mr. Lawton to prepare an order; 72-364, Soil Enrichment Corp., a hearing was authorized by a vote of 4-0; 72-365, First Nat'l. Bank of Springfield, hearing authorized by a vote of 4-0; 72-366, Lawrence Weinstein, a hearing was authorized by a vote of 4-0.
