Minutes of Regular Board Meeting October 10, 1972

All Board members were present.

The Mayor of North Chicago appeared in #72-298, City of North Chicago to request immediate action on open burning variance request. The Board decided to request additional information and to wait the EPA recommendation.

Opinions and Order were adopted by a vote of 5-0 in the following cases: ## 72-25, Bowen; 72-129, Deboer 72-197, Lake-In-The-Hills; 72-236, M & S Wood; 72-278, Neumann-Knolls; 72-294, Babbitrite.

Cases put over for decision October 17, 1972 were: ## 72-196, Rafacz; 72-199, 238, Southern Ill. Power; 72-252, Enders; 72-259, National By-Products; 72-292, USI.

Parties appeared in #72-79, Sangamo and discussion was held. The Board asked the E.P.A. to file additional information and respondent to answer by October 24, 1972.

Parties appeared in # 72-253, Olin. The Board requested the petitioner to file a summary and response to the E.P.A. recommendation. An extension of decision date was requested and the matter put over to October 17, 1972.

Meeting recessed for lunch.

In #72-81, Tee-Pak, parties appeared and filed further statements. The Board requested additional information from the E.P.A. and the matter was put over to October 17, 1972.

The Board adopted opinions and orders by a vote of 5-0 in the following cases: ## 72-297, Illinois Power; 72-301, First National Bank; 72-302, Chicago-Dubuque; 72-333, Mt. Olive.

The Board voted 5-0 to dismiss # 72-334, Highwood, and Mr. Currie agreed to prepare the opinion and order.

Mr. Dumelle made a motion to authorize a hearing in #72-350, Edison. Petitioner requested orally that the Board grant an interim variance and the Board voted 5-0 to do so. Mr. Dumelle agreed to prepare an order.

After some Board discussion, Mr. Henss agreed to prepare an opinion in #72-243, Frye, for decision October 17, 1972.

A motion for reconsideration in #71-365, Urbana, was denied by a vote of 5-0 and Mr. Currie said he would prepare the order.

Two motions to dismiss in #72-179, E. Lawn Water were ordered taken with the case.

A motion to adopt hearing officer orders as Board orders in #72-186, Evanston, was put over to October 17, 1972.

In #72-288, Acme, the Board voted 5-0 to overrule hearing officer order on continuance and Mr. Lawton agreed to prepare the order.

In #72-328, Peabody Coal, a motion to add parties was ordered to the Hearing Officer for decision and the application for non-disclosure put over to October 17, 1972.

A motion to dismiss in #72-343, Meadowlark, was ordered taken with the case.

In #72-364, Semco, motion for briefs in lieu of hearing was put over to October 17, 1972.

The E.P.A. recommendation in #72-378, Grant Park, was filed. The Board put it over for discussion October 17, 1972.

The financial report was put over to October 17, 1972.
