MINUTES OF REGULAR BOARD MEETING.
November 8, 1972 Chicago, Ill.

All Board Members were present.

The Board adopted opinions and orders in the following cases: ## 72-72, Kienstra, vote of 5-0; 72-83, Cilco, vote of 5-0; 72-175, W. Frankfort, vote of 5-0; 72-230, C. M. Ford, vote of 5-0; 72-260, Deters; 72-313 and 72-314, Lansdowne and Cahokia, vote of 5-0; 72-339, Liberty Financial, vote of 5-0; 72-398, N. Chicago, opinion only, vote of 5-0; 72-416, Incinerator, opinion only, on motion for interim variance, vote of 5-0;

Decisions in ## 72-76, Fansteel (opinion only) and 72-80, Harrisburg were put over to November 14.

The Board adopted Amendments to Open Burning Regulations (R72-11) by a vote of 5-0. Mr. Henss will prepare an opinion for November 14. The Board voted 5-0 to file the amendments with the Secretary of State on an emergency basis.

Parties were present in the matter of # 72-308, General Iron on petitioner's emergency motion for stay. The motion was denied by a vote of 5-0. Mr. Currie will prepare the order. The proceedings were transcribed.

An opinion and order in #72-81, Tee-Pak was adopted by a vote of 4-1, Mr. Dumelle dissented. A Separate order on non-disclosure was adopted by a vote of 4-1, Mr. Henss to prepare the order.

An amended petition in #72-386, Monarch Foundry was authorized for hearing and ordered consolidated with #71-386, EPA v. Monarch Foundry.

Discussions were held in these cases and set for Decision. November 14: ## 72-159, Woodstock, Mr. Currie to prepare an opinion; 72-329, W. Salem, Mr. Currie to prepare an opinion; 72-179, E. In #72-389, Donaldson, action postponed pending possible comment by E. P. A.

Discussion of Procedural Rules Amendments was put over.

The Board adopted an order in #71-364, Augusta by a vote of 5-0 on motion for non-disclosure. Mr. Parker will prepare the order.

In ## 72-149 and 72-229, Lockport Trucking The Board adopted an order by a vote of 5-0 on motion for clarification. Mr. Henss will prepare the order.

A motion for modification in ## 72-105 and 72-187, S. Side Foundry was ordered held for a response from the E. P. A.

Motion for extension of time in #72-197, Lake-In-The-Hills was held pending E. P. A. response.

Motion to withdraw petition in #72-359, Knox was granted by a vote of 5-0, Mr. Currie to prepare an order.

Minutes of Board meetings held October 17, 24 and 31, 1972 were approved by a vote of 5-0.

Motion to withdraw petition in # 72-369, McGough was granted 5-0, Mr. Currie to prepare an order.

In new cases these actions were taken: ## 72-418, Capitol Development, dismissed by a vote of 5-0, Mr. Currie to prepare the order; 72-424, Scott Air Force, ordered held for E. P. A. recommendation; 72-425, Laclede, hearing authorized 5-0; 72-426, Shawnee National Forest, hearing authorized 4-1, Mr. Dumelle dissented; 72-427, Whetzel Construction, ordered held for E.P.A. recommendation; 72-428, Dostal, hearing authorized 5-0; 72-429, Montebello, hearing authorized 5-0; 72-430, Fleming, Docketed as case in eero, ordered removed; 72-431, Great Lakes hearing authorized and ordered consolidated with #72-48, E.P.A. v. Great Lakes Carbon, 5-0; 72-432, Dean Penn, hearing authorized 5-0; 72-433, E.P.A. v. Leonard Green, hearing mandatory; 72-444, Hanna, hold for E.P.A. recommendation.

A letter from the E.P.A. on permits for farm grain elevators was discussed and the Board voted to deny their request 5-0.

General discussions were held regarding fines, compliance with Board orders, and animal waste hearings.
