MINUTES OF REGULAR BOARD MEETING  
MARCH 8, 1973 CHICAGO, ILLINOIS

All Board members were present.

A motion to extend time for filing briefs in #R71-24, Beverage Containers was granted by a vote of 3-0. The time was extended to April 30, 1973. Mr. Lawton will prepare an order.

Opinions and orders were adopted by a vote of 3-0 in the following cases:

Minutes of the Board meeting held February 27, 1973 were approved 3-0.

Motion to dismiss in #72-94, Dart Industries was denied 3-0. Mr. Lawton will prepare an order.

Orders on motion for stay and motion to amend in #72-343 Meadow Lark were adopted 3-0. Mr. Lawton will prepare the orders.

A motion for reconsideration in #72-396, Sauget was put over to March 15 for consideration.

Motions to withdraw in ## 72-421, Imperial Smelting and 72-423, General Iron were Granted 3-0. Mr. Lawton will prepare the orders.

In #72-514, E. St. Louis, motion to withdraw petition as to chlorination only was allowed 3-0. Mr. Lawton will prepare an order.

In #73-21, Herrin, motions to dismiss by Jerrin and Norge and Fedders were denied. Mr. Lawton will prepare an order.

Motion to dismiss by E.P.A. in #73-53, McIntosh, was denied by a vote of 3-0. The agency was ordered to file its recommendation within 15 days and the petition was ordered taken as part of #72-506, EPA v. McIntosh. Mr. Lawton will prepare an order.

Parties will be asked to respond in #71-343, North Shore Sanitary Dist., motion for clarification. Mr. Dumelle will prepare an order and the matter was put over to March 22 for consideration.

In #70-17, Dupage Regionalization, a notion for interim relief by the city of Naperville was denied by a vote of 3-0. Mr. Lawton will prepare an order.

An order on motion for stay in #72-180, Mystik Tape was adopted 3-0. Mr. Lawton will prepare the order.

Motion to strike proposed regulations in #R72-5, Solid Waste, filed by South Suburban Land Company, was denied 3-0. Mr. Lawton will prepare an order.

Wate Quality Standards Amendments proposed by the Agency were authorized for hearing by a vote of 3-0.

A proposal on Water Quality Amendments by the consulting engineers was put over to March 15, 1973.

An amended proposal in #R72-2, Nosie Standards, by the E.P.A. was authorized for hearing.

A resolution in support of the Sierra Club was adopted by the Board by a vote of 3-0.

Mr. Henss discussed some tentative amendments to the Open Burning Regulations and the Board decided to ask the Agency and the Institute for comments.

These cases were put over to March 15 for further discussion: ##71-340, Aluminum Processing; 72-49, Harris; 72-52, 48 Insulations; 72-350, Commonwealth Edison.
