

ILLINOIS POLLUTION CONTROL BOARD

Minutes of Regular Board Meeting  
March 29, 1973 Chicago, Illinois

All Board Members were present.

Mr. Rubin of the Attorney General's office was present and discussed the matter of the Roth-Adams injunction with regard to #R71-23, Air Regulations. Mr. Rubin agreed to prepare a memorandum for the Board by April 5, 1973.

The matter of ##73-3, O'Connor v. Rockford was discussed and Mr. Rubin agreed to prepare an amicus curae brief.

An Opinion and Order in #71-319, Holland was adopted by a vote of 4-0.

In #72-49, Benjamin Harris, an Opinion and Order was adopted by a vote of 3-0. Mr. Lawton did not participate in the discussion or decision of the matter.

Opinions and Orders were adopted in #72-134, Salt Creek and in 72-200, DuQuoin by a vote of 4-0.

An Order was adopted in #72-350, Commonwealth Edison by a vote of 3-1. Mr. Dumelle dissented and will file a dissenting Opinion. Mr. Lawton will prepare the Opinion and Order.
