All Board Members were present.

An Opinion and Order was adopted in ##72-51, CPC by a vote of 3-0. Mr. Henss was not present for the vote.

Parties were present for Oral Argument in ##71-4, -33, and 72-85, Fry Roofing Co. After statements were presented and some discussion the Board decided to place the matter on the Agenda June 28 for decision. Mr. Lawton will prepare a draft Opinion for consideration.

Mr. Rubin of the Attorney General's Office reported to the Board on the status of the Steel Companies' motions for stay.
