Opinions and Orders were adopted in the following cases by a vote of 4-0: ##73-72, Popp; 73-212, CPC; 73-257, Wagner; 73-267, Watson; 73-271, Kramer; 73-328, Ashland.

An Opinion and Order was adopted in #73-133, Marquette, by a vote of 4-1, Mr. Dumelle dissented.

An Opinion and Order was adopted in #73-274, Thompson, by a vote of 4-0, Mr. Marder abstained.

These cases were discussed and set for possible decision on September 26, 1973: ##72-491, -492, and 73-40, Commonwealth Edison; 73-210, Buckles v. Pope; 73-247, St. Charles & Swift.

Motion to reconsider in #71-381, Peterson, was discussed and set for further consideration on September 26, 1973.

In #72-188, Ashland, motion for extension of time to file compliance program was ordered held pending Agency response.

In #73-74, Reliance, motion for modification was discussed and set for further consideration September 26, 1973.

In #73-140, Alton Box Board, the Board adopted an order requesting advisement as to attorney handling appeal by a vote of 5-0.

Motion for reconsideration and motion to dismiss motion for reconsideration was discussed and set for further discussion Sept. 26.

In #73-268, Near Ones v. EPA, parties were present on motion to dismiss. The Board requested that briefs be filed on the motions to dismiss.

Motion to decide without hearing was granted in #73-301, Board of Regents by a vote of 5-0. Mr. Dumelle will prepare an order.

Motion to cancel hearing and decide without hearing in #73-325, DuPont was granted 4-0. Mr. Dumelle will prepare an order.

Motion to extend comment period in R70-17, DuPage, Region II, to October 12, 1973 by "Citizens" was granted 5-0. Mr. Dumelle will prepare an order.

Motion for stay of Noise Regulations, R72-2, by Ill. R.R. Assoc. was denied 4-1. Mr. Henss dissented. Mr. Dumelle will prepare an order.

In ##72-489, and 73-184, Stephen Chemical, the Board adopted an order severing the enforcement case from the variance if extension of waiver not filed by a vote of 5-0. Mr. Henss will prepare an order.
