Minutes of Regular Board Meeting
April 4, 1974 Chicago, Illinois

All Board Members were present.

Opinions and orders were adopted by a vote of 5-0 in these cases: ##
73-329, Kipling; 74-12, Danville Sanitary District; 74-13, Amerock;
74-21, Benj. Harris; 74-24, G.E.

Motion for stay in #73-193, Fleischman, was allowed as to penalty only
by a vote of 4-1, Mr. Marder dissented. Mr. Seaman will prepare an order.

Petition for rehearing in #73-65, CILCO was denied 4-1, Mr. Henss dissented.
Mr. Marder will prepare an order.

Motion to include pertinent document into the record in #73-454, Early and
Daniel was allowed 5-0. Dr. Odell will prepare an order.

Motion to dismiss in #73-539, Reichhold Chemicals was ordered taken with
the case. Hearing was authorized on #73-539 and #74-111, Reichhold,
variance and permit denial. Vote was 5-0, Mr. Henss will prepare an order.

Motion for interim variance in #74-11, Commonwealth Edison was granted
5-0. Mr. Dumelle will prepare an order.

Timely objection having been filed in #74-90, Ridgeview Development, a
hearing was authorized.

Motion to dismiss by petitioner in #74-91, County of Piatt was allowed
5-0. Mr. Henss will prepare an order.

Motion for extension of comment period in R72-9, Feedlots, was allowed
until 10 days after adoption of R73-11, -12, NPDES. The vote was 5-0,
Dr. Odell will prepare an order.

Comment period in R73-9, Complex Sources was extended to June 30, 1974,
by a vote of 5-0. Mr. Seaman will prepare an order.

Minutes for Board Meetings held March 21 and 28, 1974 were approved
by a vote of 5-0.

These cases were discussed and set for further discussion or possible

Oral argument was heard in #74-83, Rutland EPA v. Board of Supervisors et al.
The Board held the case until April 18 for determination on whether or not
a hearing would be authorized.

Hearings were authorized in these citizen enforcement actions: ##74-85, Hromec v. Lakeland Park Water Co; 74-104, CBE v. Kraft Foods; 74-105, CBE v. Lauhóff Grain.

#74-103, C.B.E. v. Briceland et al was discussed and held to April 18. Harvey Sheldon of the U.S.E.P.A. presented a statement.

In new cases these actions were taken by a vote of 5-0: ##74-115, Borg-Warner, ordered held for additional information and Agency recommendation; 74-116, Scott Air Force Base, hold for Agency recommendation; 74-117, Springfield Marine Bank, hearing authorized; 74-118, Greenlee Bros., ordered held for Agency recommendation and additional information; 74-119, Deere & Co., ordered held for Agency recommendation; 74-120 through 74-123, Amoco Oil, ordered held for Agency recommendations; 74-124, EPA v. City of Rockford et al, hearing mandatory; 74-125, GATX, ordered held for Agency recommendation, 74-126 Texaco, additional information requested and ordered held for agency recommendation; 74-127, City of White Hall, held for Agency recommendation and additional information requested; 74-128, Ill. Community Hospital, ordered held for Agency recommendation. Mr. Dumelle will prepare all additional information orders.

R73-11, -12, NPDES regulations were discussed. A proposed draft of Part A was authorized for publication and public comment by a vote of 4-1, Mr. Marder dissented. Sub-part B was authorized for hearing by a vote of 5-0.

Citizens for a Better Environment presented a comment regarding Board Procedural Rule 307 and specifically #74-87, C.B.E. v. Commonwealth Edison. The Board made no comment.

All matters not disposed of as listed were ordered placed on the Agenda for April 18, 1974.
