MINUTES OF REGULAR BOARD MEETING
April 13, 1978 Chicago, Illinois

All Board Members were present.

Opinions and Order were adopted in these cases by a vote of 5-0:

An Opinion and Order was adopted by a vote of 4-1, City of
Wyoming, PCB77-252, Mr. Young dissented.

An Order was adopted in #78-25, Orland Trails by a vote of 4-1,
Dr. Satchell concurred and Mr. Young dissented. The Order will
be prepared by Mr. Goodman and an Opinion will be considered on
April 27, 1978.

Motions to Amend and for Extension were granted in #77-37, John
Daubs by a vote of 5-0. Mr. Dumelle will prepare an Order.

Waiver of hearing in #77-273, Katz was denied by a vote of 5-0.
Mr. Goodman will prepare an Order.

Motion for Rehearing in #77-332, Crystal Lake was granted by a
vote of 5-0. A hearing will be held and the 90-day decision period

#78-26, West Chicago was dismissed for failure to respond to the
Board Order requesting additional information. The vote was 5-0.

Motion to dismiss #78-28, Rapid Liquid Waste was denied by a vote
of 5-0. Mr. Goodman will prepare an Order.

Motion For Extension of Time to File Recommendation in #78-48,
Rexene Styrenics was granted by a vote of 5-0. Mr. Dumelle will
prepare an Order.

Motion to Dismiss Permit Appeals by Petitioner in ##77-239 - 77-
247, City of Springfield was granted by a vote of 4-0, Mr. Young
abstained. Mr. Goodman will prepare an Order.

Motion for Extension of Time in #78-60, Olin Corporation was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to Withdraw Petition in #78-80, Illini Beef was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

The Amended Petition in #78-24, Department of the Army was ordered held for an Agency recommendation.

An Amendment to the Open Burning Regulations was filed under R78-2 and adopted on an Emergency Basis by a vote of 5-0. Mr. Dumelle will prepare the Order.

R74-2, R75-5 and R76-9, Sulfur Dioxide Regulations was discussed and held to April 27, 1978 for further discussion.
