Minutes of Regular Board Meeting
May 10, 1979 Chicago, Illinois

All Board Members were present.

Opinions and Orders were adopted in these cases by a vote of 5-0: ##77-341, Ordman's Park; 78-35, Robertson; 78-114, Waukegan Port District (Opinion only); 78-241, Granite City Steel; 78-249, American Nickeloid; 79-23, E.W. Kneip; 79-36, Monmouth; 78-213, Tweedy; 79-50, Champaign and Urbana Sanitary District; 79-31, Village of Cisco.

A final Opinion and an Order were adopted in R77-12, Water Pollution Regulation Amendments, Docket A, by a vote of 5-0.

An Opinion was adopted in R76-1, WQS Amendments by a vote of 5-0.

Appendix A to the Board's Procedural Rules was adopted under docket number R79-5 by a vote of 5-0.

A proposed Order was adopted by a vote of 5-0 in R77-14, Landfill Distances.

An Order of consolidation was adopted in R79-6 and R79-8, Proposed WQS Amendments, by a vote of 5-0.

Motion to amend in #78-50, North Shore Sanitary District, was adopted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to amend in #78-236, Kaney Transportation, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

An Order was adopted in #78-311, Olin Corporation, pursuant to a motion for relief, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to withdraw was granted by a vote of 5-0 in #78-314, Mobil Oil. Mr. Dumelle will prepare an Order.

Motion for extension of time was granted in #79-9, Beker Industries, by a vote of 5-0. Mr. Goodman will prepare an Order.

A supplement and amendment to petition filed in #79-29, Olin Corporation, was construed as a request for hearing. A hearing was authorized by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for extension of time was granted in #79-65, Stauffer Chemical, by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion for stay of permit conditions was granted in #79-71, Minnesota Mining, by a vote of 5-0. Mr. Goodman will prepare an Order.

A stipulation for extension of time to file a recommendation was granted by a vote of 5-0 in #79-73, Simmons Mfg. Mr. Goodman will prepare an Order.

A resubmitted application in #79-81, Reynolds Metals, was accepted and the matter was re-opened and authorized for hearing. The vote was 5-0, Mr. Goodman will prepare an Order.

A joint motion for dismissal was granted in #79-14, Outboard Marine, by a vote of 5-0. Mr. Dumelle will prepare an Order.
