

ILLINOIS POLLUTION CONTROL BOARD
MINUTES OF REGULAR BOARD MEETING
APRIL 17, 1980 CHICAGO, ILLINOIS

All Board Members were present.

An Opinion was adopted in #75-13, Interlake, by a vote of 4-0, Mrs. Anderson abstained.

Opinions and Orders were adopted in these cases by a vote of 5-0: ## 78-238, Plano; 79-60, Illinois Tank and Truck Wash; 79-241, Earlville; 79-264, H. Bergman (Order only);

An Opinion and Order was adopted in #79-177; Nichols, by a vote of 4-0. Mr. Werner abstained and Mr. Goodman concurred.

An Order was adopted in R74-2, R75-5, Sulfur Dioxide by a vote of 5-0.

Motion to file exhibits in #79-11, Brogan v. Palos Hills, was granted by a vote of 5-0. Mr. Dumelle will prepare an Order.

Motion to modify in #79-58, Minerals Mgt., was granted by a vote of 4-1, Mr. Werner dissented. Dr. Satchell will prepare an Order.

Motion to clarify was granted in #79-159, Algonquin, by a vote of 5-0. Mr. Goodman will prepare an Order.

Agreed motion to stay was granted in #79-276, Monterey Coal, by a vote of 5-0. Dr. Satchell will prepare an Order.

Motion to dismiss #80-36, B.E.R.D.S., was granted by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss was held in R71-9, R80-1, Radiation, and parties were asked to submit briefs. The vote was 5-0, Mr. Dumelle will prepare an Order.
