Minutes of Regular Board Meeting October 17, 1980 Chicago, Illinois

All Board Members were present save Mr. Dumelle who was attending an Economic Impact Hearing in the matter of Beverage Container Regulations.

An Order was adopted in R80-7, Procedural Rules, Permits, ordering that the Proposed Rule be filed as a Second Notice. The vote was 3-1, Mr. Werner dissented.

A Resolution Order was adopted in R80-17, Illinois Power, Cooling Lakes by a vote of 4-0.

R80-18, Procedural Rules Amendments, Rules 304 and 308 was adopted as a Proposed Rule, First Notice by a vote of 4-0.
