MINUTES OF REGULAR BOARD MEETING  
June 16, 1983 Chicago, Illinois

All Board Members were present.

The bids for court reporting services for FY 84 were discussed. The contract was awarded to the firm of Longoria and Goldstine.

Only one bid was received for photocopier/duplicating services for FY 84. The contract was awarded to Eastman Kodak.

An Interim Order was adopted in #82-149, Jack Rich, by a vote of 4-0.

Opinions and Orders were adopted in these cases by a vote of 4-0: #82-152, Village of Lombard,; 82-156, St. Charles Manufacturing.

An Interim Order was adopted in R80-22, SO<sub>2</sub>, for Winnetka, by a vote of 4-0.

A Proposed Rule, Second Notice and Proposed Opinion was adopted in R81-16, Docket B, Air Permits, by a vote of 4-0.

A Final Opinion and Order was adopted in R81-29, Pfizer, by a vote of 4-0.

A Resolution and Order was adopted on R83-13, New Source Performance Standards, by a vote of 4-0.

In #83-46, Olin, the Board adopted an Order pertaining to the conduct of a hearing. The vote was 4-0, Mr. Dumelle will prepare an Order.

The Board decided to grant the petitioner's request to decide without hearing in #83-48, Lockport. Mr. Dumelle will assign to a Board Member for review.

Instead of granting a motion to dismiss in #83-56, Alco Gravure, the Board requested petitioner to file an amended petition. The vote was 4-0, Mr. Dumelle will prepare an Order.

Motion to file records instanter were granted in #83-58,-59, Caterpillar, by a vote of 4-0. Mr. Dumelle will prepare an Order.

Request to clarify in #83-70, Shelbyville, was held to June 30, 1983.

Motion to correct the Order in R80-22, SO<sub>2</sub>, was held to June 30, 1983.

Petition to withdraw proposal in R82-21, Waste Permits was granted by a vote of 4-0. R82-22, Landfill Operating Criteria was also dismissed by a vote of 4-0. Mr. Anderson will prepare an Order.

An Order was adopted in ## 82-132, -133, Will County, requesting information on the status of the cases. The vote was 4-0, Mrs. Anderson will prepare an Order.

The amended petition filed in #83-65, Bob Evans, was ordered held for an Agency recommendation.

In Interim Order was adopted in #80-117, Revere Copper and Brass, by a vote of 4-0.
