All Board Members were present.

Motion to require the Agency to issue a permit in #78-177, Celotex, was denied by a vote of 5-0. Mr. Goodman will prepare an Order.

Motion to dismiss in #78-178, New Jersey Zinc, was granted by a vote of 5-0. Mr. Anderson will prepare an Order.

In #80-126, Olin, motion for oral argument was denied, motion for inclusion was ordered taken with the case. The vote was 5-0. Mr. Anderson will prepare an Order.

Motion to lift stay was denied and the briefing schedule was revised in ##80-189,-190, Alburn, by a vote of 5-0. Mrs. Anderson will prepare an Order.
