MINUTES OF REGULAR BOARD MEETING AUGUST 3, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning welcomed member of the public and staff, announced that the Board meeting originally scheduled for August 17, 1995, was changed and will be held August 24, 1995, welcomed former Board Member Joan Anderson to the meeting. Thereafter, the Clerk was asked for a role call and all Board Members answered present except R.C. Flemal and M. McFawn, who were on vacation.
