MINUTES OF REGULAR BOARD MEETING AUGUST 24, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning asked the Clerk for a role call and all Board Members answered present.

In R95-9, Amendments to 35 Ill. Adm. Code 810.103 (Solid Waste Disposal General Provision) Concerning On-Farm Disposal of Dead Animals, a Proposed Rule, Second Notice, Opinion and Order was adopted by a vote of 7-0. (RCF)

In R95-14, Petition of the Metropolitan Water Reclamation District of Greater Chicago for Site-Specific Water Quality regulations for Cyanide (Amendments to 35 Ill. Adm. Code 302, 303, and 304, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 7-0. (RCF)

A joint motion to modify proposed adjusted standard language will be taken with the case-in-chief in AS 94-4, Petition of Chase Products Company and IEPA for an Adjusted Standard from 35 Ill. Adm. Code 218, Subpart DD.

An Opinion and Order was adopted in AS 94-15, Petition of Lone Star Industries, Inc. for an Adjusted Standard from 35 Ill. Adm. Code 811.320(d) (Establishment of Groundwater Background Concentrations), by a vote of 7-0. (JTM)

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$42,500.00, was adopted in \$96-7, People of the State of Illinois v. Acme Wiley Corporation, by a vote of 7-0.

An Opinion and Order accepting the Stipulation and Proposal for Settlement in the amount of \$11,000.00, was adopted in #96-11, People of the State of Illinois v. Elmhurst-Chicago Stone Company, by a vote of 7-0.

A Final Opinion and Order assessing costs, was adopted in #AC 94-73, IEPA v. Stacy B. Hess, by a vote of 6-1. J. Yi dissented and J. Theodore Meyer concurred. (RCF)






