MINUTES OF REGULAR BOARD MEETING SEPTEMBER 21, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning welcomed members of the public and staff, and introduced and welcomed Patricia Szott, who has joined the Board's staff and will serve as secretary to Board Member, Emmett Dunham, and attorney assistant, Diane O'Neil. Thereafter, the Clerk was asked for a roll call and all Board Members answered present.

In R95-9, Amendments to 35 Ill. Adm. Code 810.103 (Solid Waste Disposal General Provision) Concerning On-Farm Disposal of Dead Animals, an Adopted Rule, Final Order, Opinion and Order was adopted by a vote of 7-0. (RCF)

In R96-1, Proposed Alternative Standards for New Utility Waste Landfills, 35 Ill. Adm. Code Part 816, a Proposed Rule, First Notice, Opinion and Order was adopted by a vote of 6-1. J. Theodore Meyer dissented. (JY)

On September 7, 1995, the Board adopted a Proposed Rule, First Notice, Opinion and Order pursuant to Section 28.5, in R96-2, 15% ROP Plan: Clean-Up Part I - Amendments to 35 Ill. Adm. Code 219.585(a) and 219.Appendix E, by a vote of 6-1. J. Theodore Meyer dissented. (RCF)
