MINUTES OF REGULAR BOARD MEETING NOVEMBER 16, 1995 CHICAGO, ILLINOIS

After calling the meeting to order, Chairman Manning welcomed the members of the public and staff to the meeting. Thereafter, the Clerk was asked for a roll call and all Board Members answered present.



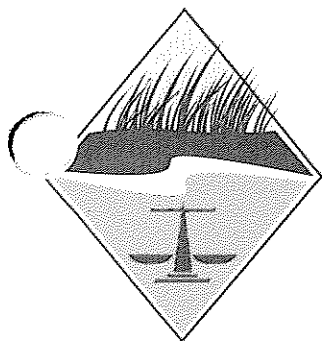

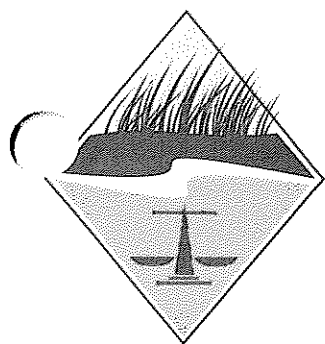
